## Information we collect

## Log Files

The use of log files is standard practice at NEA. These records keep track of who visits which websites. This is a universal practice and a component of website analytics. These are not connected to any personally

identifiable information. The information is used for trend analysis, website administration, tracking user behavior on the site, and demographic research.

## **Cookies and Web Beacons**
